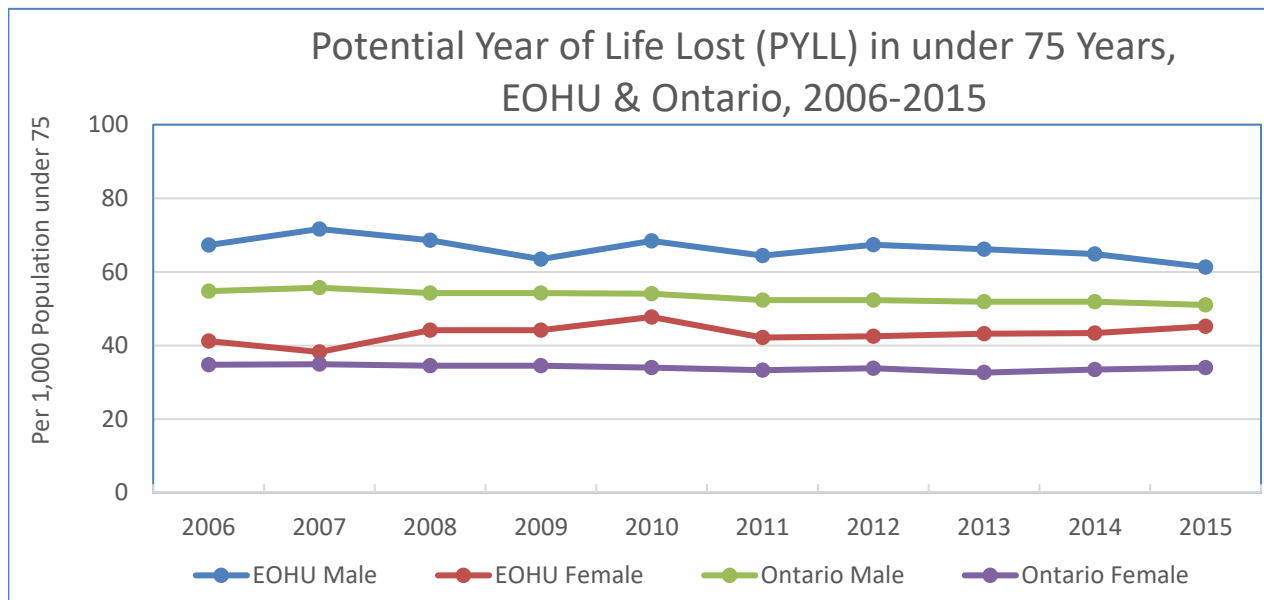

#### Potential Year of Life Lost (PYLL) per 1,000 population, 2006-2015

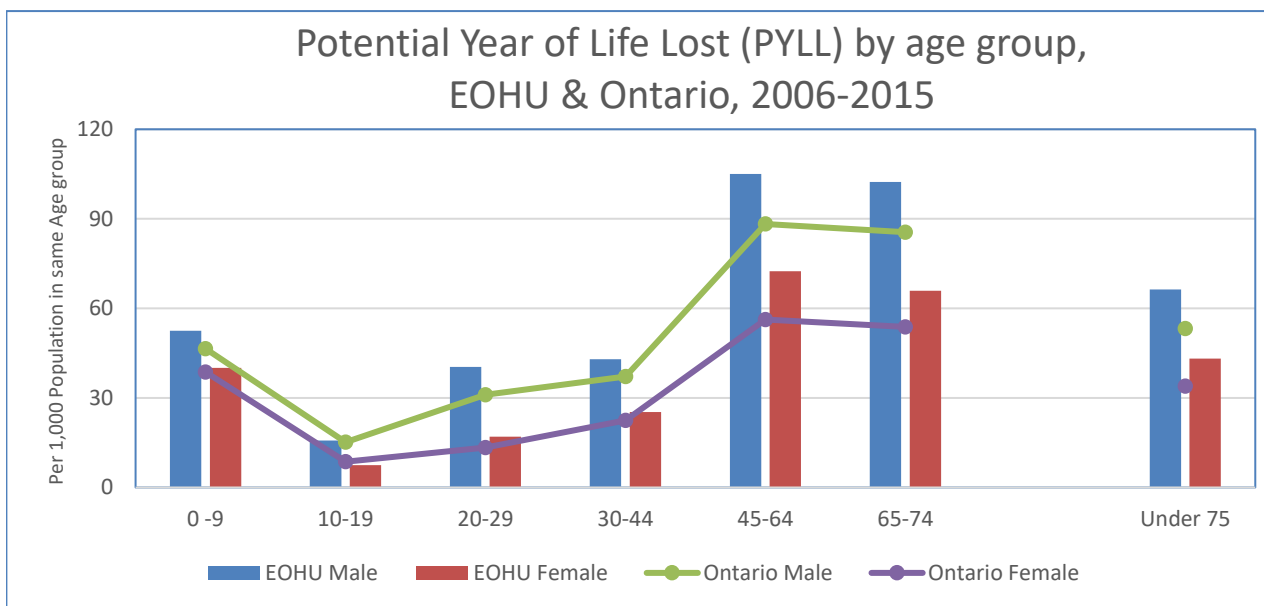
